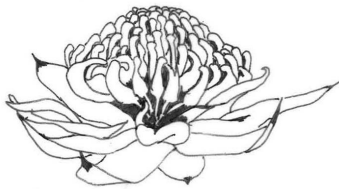

## Terms and Conditions of Membership

To be determined by the Board of the Stead Foundation

### A person who wishes to become a member of the David G. Stead Memorial Wild Life Research Foundation of Australia:

- I. should wish to foster an awareness of the unique natural and cultural heritage of Australian wild-life and environment and to promote conservation of these values
- II. must respect the autonomy and independence of all parties with an interest in the Foundation and Wirrimbirra Sanctuary
- III. must be nominated by a least one (1) member
- IV. must be approved for membership by the Stead Foundation Board as per Clause 4 of the *Articles of Association*

### Nomination for Membership

A nomination of a person for Junior, Ordinary, Concession, Student and Corporate [non-profit] membership of the Foundation shall be made by at least one member of the Foundation on the Membership Form provided. Nomination is not required for renewing memberships.

### Membership

New membership nominations must be received by 30 September for the current year. Memberships received after this date will be held over to the following calendar year.

If approved by the Board, and the sum to be paid by the member/s as an annual subscription is paid, the nominee becomes a member of the Foundation. Clause 8 of the *Articles of Association* requires annual subscriptions to be paid in advance on the first day of January in every year.

A copy of the Foundation's *Memorandum and Articles of Association* is kept at Wirrimbirra Sanctuary and is available for reading on request.

New applications and renewals are approved at the discretion of the Board. This generally (but not always) occurs at the next Board meeting after the application are received. If rejected, the Board will advise the reason/s for rejection.

### Dual Membership

Dual membership (ordinary & concession) is for two people 18 years of age or over, residing at the same address. Each person is considered a separate member of the Foundation. Only one copy of any notice or publication by the Foundation will be sent to the shared address.

### Junior Membership

Members under the age of 18 (Junior members) do not have the right to vote at general, annual or extraordinary meetings.

### Non-payment of subscriptions

Membership renewals are due on 1 January each year. Members that have not renewed will be advised in writing. A person will cease to be a member of the Foundation if the subscription payment is not received by 31 March.

### Resolution of Internal disputes

Disputes between members (in their capacity as members) of the Foundation, and disputes between members and the Foundation, are to be referred to the Board.
